  - i. Sandy Naranjo: Requested edit to recommendation 8 on the letter to include "such as

#### the draft Portside CERP's and Port of San Diego MCAS' goal"

- (A) Joy: Shared the team would be happy to add
- ii. Elisa Arias: Noted that under recommendation 3 it mentions expanding the number of trucks covered by the rule. Asked if there is a proposal for what this expansion would look like.
  - (A) Patricio Portillo: Explained there are several different ways they are looking at the rule. One is reducing the fleet threshold for which fleets would be required to comply. They would lower that threshold.
  - (B) Jimmy O'Dea: The 100% sales requirement in 2035 is also an important way to get more numbers.
- iii. Sarah Giobbi: Noticed that the rule has phase-ins for the percentage of trucks in the fleet. Would like to know if this because it takes time and resources to meet the 100% goal.
  - (A) Bruce Tuter (CARB): Acknowledged that is basically correct.
  - (B) Craig Duehring (CARB): Explained that the phase-in is to provide some flexibility to identify the trucks best suited for electrification in the early years.
  - (C) Sarah: Raised the concern that there is not much time to put everything in place. In addition, wonders how will we can plan for things five years out of the regulation if we are not five years out of the regulation.
    - a. Bruce Tuter: Explained the regulation is targeting mid 2022. In addition, the 2023 requirement is only for new trucks going into the port.
    - b. Sarah: Reiterated that she wants to make sure we are not setting up a compliance burden.
- iv. Salvador Razo Abrica: Expressed concern with burden of regulations falling on the wrong entity. There are many that don't reach the 50 truck benchmark. Emphasized that more can be done locally if we focus on the goals and relevant issues to this area. Agrees that zero emissions is the way to go, but that the burden does not need to fall on individual drivers. The words owner/ operator, independent contractors, and similar are a misnomer in the port.
- v. Danny Serrano questions in chat:
  - (A) Port staff have expressed that CARB projections showing that 51% of HD trucks will be ZEV by 2030 reflects availability of trucks. Can you please confirm that the state's projections for ZE drayage transition are based on the limitations imposed by SB 1, not on availability of heavy-duty vehicles?
  - (B) Can you please confirm that the Port is not limited by SB1 limitations and in fact can require and incentivize drayage trucks servicing the Port to transition to ZE more quickly than CARB can require?
  - (C) Can you please confirm that the Port of San Diego doesn't have to abide by CARB's drayage exemptions in developing their local program to transition to ZEV heavy duty trucks?
  - (D) How can local agencies, like the Port or transit agency, work to advance the goals of the ACF locally?
