The May 11, 2023 hearing is preparatory to adopting a budget for the District for Fiscal Year 2023-24. After considering public comments, the Governing Board intends to adopt a final budget at a second public hearing on June 8, 2023 at 2:00 PM. Any member of the general public, including any person required to pay fees to the District, may appear at either of these hearings or use any other avenue of communication made available by the District to provide comment. Written public comments received at the District prior to June 8, 2023 will also be accepted and considered.

All proposals for revisions should be submitted, in writing, to the San Diego County Air Pollution Control District Clerk of the Board via email at APCDPublicComment@sdapcd.org or received at the San Diego County Air Pollution Control District, 10124 Old Grove Road, San Diego, CA 92131 before June 8, 2023. Early submission of written comments is encouraged.
