NOTICE OF PUBLIC WORKSHOP

FOR DISCUSSION OF DRAFT PROPOSED AMENDED RULE 69.6 – NATURAL GAS-FIRED FAN-TYPE CENTRAL FURNACES

The San Diego County Air Pollution Control District (District) invites you to participate in the following virtual public workshop to provide input about draft proposed amendments to Rule 69.6 – Natural Gas-Fired Fan-Type Central Furnaces. Comments and questions concerning this proposal may be submitted in writing before or during the workshop, which is scheduled for:

As currently written, Rule 69.6 is a point-of-sale rule that applies to any new natural gas-fired, fan-type central furnace with a rated heat input capacity less than 175,000 Btu per hour, and for combination heating and cooling units with a rated cooling capacity less than 65,000 Btu per hour, which are distributed, sold, offered for sale, or installed within San Diego County. If adopted by the Governing Board, the proposed amendments would lower emission standards for nitrogen oxides (NOx), effective six months after Governing Board adoption. NOx emissions impact local and regional air quality and contribute to the formation of ozone and secondary particulate matter.

In summary, the proposed amendments to Rule 69.6 will:

- Lower the existing emission standard for furnaces (except those to be used in manufactured or mobile homes) from 40 nanograms of nitrogen oxides per joule (ng NOx/J) to 14 ng NOx/J.
- Specify new emission standards for furnaces installed in manufactured and mobile homes to not exceed 40 ng NOx/J.
- For each furnace model sold, require manufacturer certification statements, approved by the District, South Coast Air Quality Management District, San Joaquin Valley Air Pollution Control District, or Bay Area Air Quality Management District, to be provided upon request.
- Allow for alternative test methods to be used to demonstrate compliance if approved by the District.
